Javier specialises in intellectual property dispute resolution. He has acted for many clients across different industries such as the pharmaceutical, chemical and mechanical engineering as well as semiconductor industries in trademark and patent matters.

Javier is ranked a "Rising Star" for Intellectual Property for three consecutive years since 2022 by Legal 500 Asia Pacific. He was also named the regional Rising Star of the Year at the Legal 500 Southeast Asia Awards 2023. In its 2024 edition, Asian Legal Business (ALB) identified Javier as an outstanding young lawyer in the "40 under 40" survey.

Apart from his intellectual property practice, Javier has also practised in a wide array of commercial matters including company law, contract law, defamation and employment law, for both international and local clients.

EXPERIENCE

Javier has handled many types of cases before the Singapore Courts across different areas of practice. These include numerous high-value Court matters, in particular, intellectual property disputes ranging across a wide variety of industries. Amongst his clients are well-known international brands in their respective industries.

Intellectual Property Matters

Successfully represented IIa Technologies
Pte Ltd, an industry leader and

manufacturer of lab-grown diamonds with the largest diamond growing facility in the world, in a patent infringement suit commenced by Element Six Technologies Ltd, a subsidiary of the De Beers Group, in IIa Technologies Pte Ltd v Element Six Technologies Limited [2023] SGCA 5. It is safe to say that this Suit is one of the most and possibly the most complex patent infringement case that the Singapore High Court and Singapore Court of Appeal has heard. Javier was also lead counsel in highly contentious costs proceedings that went on appeal before the High Court and successfully obtained more than S\$3m in costs for the defendant.

- Acted for a Fortune 10 company in a high value patent infringement claim commenced by Salutica Allied Solutions Sdn Bhd involving Bluetooth technology. This action is part of a global patent dispute. Javier second-chaired the hearing where the team successfully struck out Salutica's claim, without prejudice to Salutica's right to refile. Salutica has since refiled the suit in the General Division of the High Court.
- Acted for KuDOS Pharmaceuticals Limited, a wholly-owned subsidiary of AstraZeneca in a patent-linkage matter against Natco Pharma Asia Pte Ltd involving 4 patents concerning Olaparib. This is part of a global litigation for Natco's generic product Olanat.
- Acting for Singapore Airlines in a series of trademark opposition and revocation actions for its iconic "Singapore Girl" mark.
- Represented Eisai Co Ltd and its related companies in a patent linkage matter for HALAVEN, an anti-cancer mediation used to treat breast cancer and lipsarcoma. This is the first litigation globally in relation to HALAVEN.

- Successfully acted for a local skincare brand in a matter involving claims of passing off, copyright infringement and breach of contract. This matter engages novel issues in Singapore relating to use of well-known person's (e.g. celebrity) portraits.
- Successfully acted for a popular local hairremoval company in a claim involving passing off and copyright infringement. This matter engages novel issues relating to copyright infringement and passing off for interior design and style of branding.
- **Represented Tanaka Electronics** Singapore (Pte.) Ltd. in a Singapore High Court patent infringement action in Singapore HC/Suit No. 606/2020 in which we defended the patent infringement action. The action was part of the global patent litigation dispute with Nippon Steel Chemical & Material Co., Ltd. and Nippon Micrometal Corporation. Tanaka Electronic Singapore (Pte.) Ltd. owns a manufacturing facility in Singapore manufacturing bonding wires for semiconductors. Nippon Steel alleged that Tanaka Electronics Singapore (Pte.) Ltd. infringed Singapore Patent No. 2010038305 and prayed for, amongst others, an injunction. Tanaka Electronic Singapore (Pte.) Ltd. has denied infringement and has put in issue the validity of the asserted patent claims. The Singapore action has since been discontinued.
- Successfully acted for Uni-Drive (S) Pte Ltd in a revocation action filed by Nidec Control Techniques Limited ("Nidec"), a multinational corporate headquartered in the United Kingdom for a revocation action for trade marks.

Other contentious corporate matters

 Acted as lead counsel and successfully defended a client in a matter involving amongst others, breach of director's duties, passing off and conspiracy to injure. Javier obtained a swift victory for the client by obtaining a declaration from the Court that matters were already settled in an agreement, thereby preventing the matter from escalating further. The application for declaration dealt with the novel issue in Singapore of whether a settlement agreement could settle unknown and even fraudulent claims, as well as claims that arose after the date of settlement.

- Acted for Edge Capital Fund SP2 Pte Ltd, an asset management firm in a suit against doctors in Singapore involving the manufacture, supply and storage of mesenchymal stem cells under the new Regulations in the Health Products Act. This case involves tackling novel issues in relation to interpretation and application of the Regulations. The case also involves breach of directors' duties, breach of contract and misrepresentation.
- Successfully represented BW Automobiles Pte Ltd in the State Courts ([2018] SGDC 189) and in the appeal to the High Court in a landmark case concerning the interpretation of named driver insurance policies.
- Represented a Singapore holding company in the business of acquiring aesthetic practices in a suit canvassing various issues including a breach of contract, minority shareholder oppression and equitable winding up pursuant to s254 of the Companies Act. The claim was in excess of SGD20m.
- Appointed as a mediator for a multi-million estate matter involving assets in various jurisdictions and successfully assisted the parties in reaching a settlement for a dispute that lasted for more than 2 years.
