The appeal against this matter was dismissed by the High Court of Singapore (no written decision available).

- Louis Vuitton Malletier v. Megastar Shipping Pte Ltd [2017] SGHC 305 – Acted in a landmark trademark infringement matter that involved the transshipment of counterfeit fashion merchandise through the Singapore ports.
