## ABOUT YVONNE

Yvonne actively practices in all aspects of Intellectual Property (IP) work. She has more than 25 years of experience in IP matters, having devoted her entire legal career to the IP field, and her clients include multinational and local companies alike.

On contentious IP matters, Yvonne's key areas include trade marks and copyright infringement, and passing off. She is regularly involved in trade mark opposition proceedings, and has handled criminal raids of counterfeit goods as well as domain name recovery claims under the Singapore Domain Name Dispute Resolution Policy (SDRP).

Yvonne's legal experience extends to trade mark and patent registration, searches and strategic advisory work, as well as corporate IP matters, such as the drafting and review of licensing and franchise agreements relating to IP assets.

She has contributed to a number of articles on IP, including Atkin's Court Forms – Singapore, Copyright, Lexis Nexis.


Yvonne is the co-Chairperson of the Asian Patent Attorneys Association (APAA) Publications Team, Vice-President of the APAA, Singapore Group, and a member of the Institute of Singapore Trade Mark Agents. She is also a Fellow of the Singapore Institute of Arbitrators, and a Certified Patent Valuation Analyst.

## EXPERIENCE

Yvonne has handled various matters in court. Here is a sampling of her high profile matters:

- **Combe international Ltd v Dr August Wolff GmbH & Co. KG Arzneimittel [2022] SGHC 78** – Successfully acted for Dr. August Wolff GmbH & Co. KG Arzneimittel in the High Court in defending an appeal by Combe international Ltd. As part of a long-running and multi-jurisdictional dispute between parties involving several trade

marks, Dr Wolff overcame Combe's opposition, at the Trade Marks Registry and the High Court, to achieve registration of its "Dr. Wolff's Vagisan" trade mark.

- **Digi International Inc. v Teraoka Seiko Co., Ltd [2021] SGHC 165** – In a trade mark dispute between parties spanning multiple jurisdictions and concerning the Internet of Things (IoT), Yvonne successfully acted for Teraoka Seiko, at the Trade Marks Registry and also subsequently in the High Court when an appeal was brought by Digi, in opposing Digi's application for a similar trade mark, in respect of similar goods and services.
- **adidas International Marketing BV v Lutong Enterprise Corp, HC/TA15/2018 (unreported)** – Successfully represented adidas in an appeal to the High Court, against the opposition decision of the Trade Marks Registry. In this publicised case, not only was adidas successful in blocking the other party's application of a trade mark that was similar to the adidas "" mark, the High Court recognised that the adidas mark was a well-known trade mark in Singapore.

- **The Scotch Whisky Association vs Isetan Mitsukoshi Ltd [2019] SGHC 200** – Represented Isetan in the Trade Marks Registry and High Court, in defending trade mark opposition proceedings brought based on geographical indication rights claimed over "Tartan".

- **Hai Tong Co (Pte) Ltd v Ventree Singapore Pte Ltd and another appeal [2013] SGCA 260** – Successfully assisted in representing Hai Tong in the High Court and Court of Appeal in a trade mark infringement / passing-off action against Ventree Singapore Pte Ltd and SKY (sued as a firm), to stop them from infringing Hai

Tong's "Rose Lady" mark by using the mark "Lady Rose" for the same products.

- **Virtual Map (Singapore) Pte Ltd v Singapore Land Authority and Anr [2009] SGCA 2** – Successfully assisted in representing Singapore Land Authority in the High Court and Court of Appeal. In this highly publicised case, Yvonne assisted in defending SLA in Virtual Map's appeal against judgments that its online maps infringed SLA's copyright. This matter was one of Asia IP's Landmarks of the Year: The Cases and Decisions Making Headlines in 2008.
- **Future Enterprises Pte Ltd v McDonald's Corporation [2007] SGCA 18** – Successfully assisted in defending McDonald's in an appeal to the Court of Appeal. Future applied to register the "MacCoffee" mark but McDonald's had an earlier registration for "McCAFE".
- **Lifestyle 1.99 Pte Ltd v S\$1.99 Pte Ltd [2000] 2 SLR 766** – Assisted in representing S\$1.99 Pte Ltd in the High Court and Court of Appeal in its passing-off claim involving the use of a trading name.

Other notable matters include:

- **Henkel Polybit Industries Ltd v Polybit Industries Far East Sdn Bhd [2024] SGIPOS 2** – In this consolidated action for an invalidation and opposition against 7 marks, Yvonne successfully acted for the Initiator in invalidating and opposing the Respondent's various marks, based on its earlier rights under copyright, and on bad faith grounds.
- **Stora Enso Oyj v PT Purinusa Ekapersada and PT Pabrik Kertas Tjiwi Kimia Tbk Ltd [2016] SGIPOS 12** – Successfully acted for the Applicants in defending an opposition brought by Stora Enso Oyj to its application for the trade mark "ENZA" for paper related products, on the basis of similarity with the Opponents' "Storaenso" marks.
- **Tsung-Tse Hsieh v Redsun Singapore Pte. Ltd. [2015] SGIPOS 1** - Successfully acted for Redsun in invalidating the Applicant's registration, on the basis that its use is liable to be prevented by the law of passing-off.

- **Kenzo v Tsujimoto Kenzo [2013] SGIPOS 2** – Successfully acted for Tsujimoto Kenzo, the founder of the Japanese listed company, Capcom Co., Ltd, in defending an opposition brought by Kenzo to his application for the trade mark "KENZO ESTATE" in relation to wines from his Napa Valley winery.
- **Nutricia International B.V. v Societe Des Products Nestle S.A [2009] SGIPOS 6** – Successfully represented Nutricia in the Trade Marks Registry in opposing Nestle's registration of a trade mark "PROTECT", on the basis that it was not sufficiently distinctive in relation to dietetic foodstuffs, food substances and the like.
- **Samsung Electronics Co., Ltd v Funexpress.com.sg Pte Ltd (SDRP-2002-0004(F))** – Successfully represented Samsung in a domain name recovery action under the SDRP, to recover the domain name samsungmobile.com.sg.
- **PSS 1629/99: PP v Ong Choon Kin** – Successfully commenced and prosecuted a private criminal summons action for trade mark offences involving counterfeit motorcycle accessories.
