He has also acted in a variety of general commercial disputes including shareholder disputes, breach of contract, misrepresentation, unjust enrichment and employment disputes. He has appeared before all levels of the Singapore Courts as well as the IPOS Registry.

In addition to his contentious practice, Fang Hui also regularly advises on a broad range of non-contentious matters relating to intellectual property, including general brand protection, transaction due diligence, licensing, acquisitions, assignments, co-existence agreements and collaboration agreements.

EXPERIENCE

Intellectual Property Disputes
