## ABOUT CAVINDER

Cavinder is the Chief Executive Officer of Drew & Napier. He has an active practice in complex litigation and international arbitration. He is engaged in trial and appellate advocacy at all levels of the Singapore Courts and appears as counsel in international arbitration in various countries. He is also co-head of the Competition Law & Regulatory Practice.

Cavinder graduated with First Class Honours in law from Oxford University in 1992, winning the Bellot Prize for Public International Law from Trinity College. He was called to the Bar of England & Wales the following year, placing fourth in the Bar examinations. He returned to Singapore and passed the Singapore Bar exams, winning two prizes, including the prize for top candidates.

Cavinder worked for the Chief Justice of Singapore as a Justices' Law Clerk before joining Drew & Napier in 1994 as a litigation associate. In 1995, he was awarded the Lee Kuan Yew Scholarship and left for Harvard Law School where he received an LL.M. He passed the New York Bar exams and was admitted to practice in New York. Cavinder practiced as a litigation associate with Sullivan & Cromwell in New York until late 1997 when he returned to Singapore and Drew & Napier. He was made a partner of Drew & Napier in 1998 and a Director of the firm in May 2002. He was appointed Senior Counsel by the Chief Justice of Singapore in 2008, one of a handful accorded the honour before the age of 40.

Cavinder is on the Governing Board of the International Council for Commercial Arbitration (ICCA), is Vice-President of the Court of Arbitration of the Singapore International Arbitration Centre and on the

Advisory Board of the AFSA International Arbitration Rules Drafting Committee. He was a member of the World Bank Sanctions Board from 2018 to 2023, a former Vice-President of the Asia Pacific Regional Arbitration Group, and served as Chairman of the Singapore Stock Exchange's Disciplinary Committee from 2017 to 2023. He was also a member of the Securities and Industries Council from 2016 to 2022. Cavinder was a member on the inaugural Disciplinary Tribunal of the International Association of Athletics Federations (IAAF).

## EXPERIENCE

Cavinder is known among clients and peers as an extremely versatile litigator. He has handled many high profile matters for clients ranging from the governments of Laos, India and Djibouti to companies and financial institutions like UBS AG and Sharp Corporation, and even the central bank of Singapore. Here are just a few of these matters:

### Litigation

- **Securing a US\$926 million judgment for a former Prime Minister of Georgia against Credit Suisse Trust**

Representing Bidzina Ivanishvili, a former Prime Minister of Georgia, and his family in successfully claiming US\$926 million against Credit Suisse Trust Limited for breach of trust leading to losses in an investment portfolio worth over US\$1 billion. The trustee had successfully obtained a stay of proceedings in favour of Switzerland in the High Court, following which the Ivanishvili family instructed Cavinder to take over the case. Cavinder implemented a change of strategy and succeeded in the appeal before the Court of Appeal which

lifted the stay of proceedings. The matter was heard in Singapore as the Ivanishvili family had wanted and the trustee was ultimately ordered to pay US\$926 million to Ivanishvili by the SICC in its latest ruling.

- **Trust case in Singapore with disputed assets worth up to US\$800 million**

Successfully acted for members of the De La Sala family in a trust case involving disputed assets estimated to be worth between US\$600 and US\$800 million. The High Court's judgment was a landmark decision setting out guidance on what constitutes impermissible witness coaching, an issue that arose during the trial pursuant to Cavinder's cross-examination of several key witnesses.

- **Billion-dollar fraudulent trading case in Singapore**

Lead counsel for Hin Leong's liquidators in the largest reported fraudulent trading case in Singapore, in which the liquidators successfully secured a judgment of the full claimed sum of US\$3.5 billion from the directors of the company. The dispute includes claims of fabrication of gains, forgery of documents and manipulation of accounts to conceal massive losses sustained by the company over many years. This marks the collapse of one of the world's largest oil and commodities trading companies and has attracted significant media attention both locally and globally.

- **First actions for civil penalties under the Securities and Futures Act**

Represented Singapore's central bank, the Monetary Authority of Singapore, in two actions for breaches of the Securities and Futures Act (SFA). The first action was for market manipulation while the second concerned insider trading. These were the first two civil penalty cases brought by the central bank and it was the first time the central bank had instructed external counsel to appear for it in Court. Cavinder was successful in both trials as well as in both the subsequent appeals. The Court of Appeal's judgments in both cases are considered landmark decisions.

- **Represented Takashimaya subsidiary in a \$33 million dispute with REIT**

Represented a subsidiary of the Japanese Takashimaya conglomerate in a dispute over its contract with its REIT landlord. The

dispute concerns issues of commercial propriety in contract law and concerns one of the most iconic shopping and commercial properties in Singapore. Cavinder acted both in the first instance hearing before the High Court as well as in the appeal before the Court of Appeal.

- **Minority Shareholder Disputes**

Acted in numerous minority shareholder cases including *Thio Syn Kym Wendy and others v Thio Syn Pyn and others and other appeals* [2018] 2 SLR 788 and a recent case involving an Indonesian based conglomerate worth more than US\$4 billion.

- **Represented the Government of Laos in a jurisdictional challenge in respect of an investor state arbitration**

Represented the Government of Laos in its challenge to the jurisdiction of an arbitral tribunal constituted under the UNCITRAL Arbitration Rules before the High Court and Court of Appeal of Singapore. This was the first time a jurisdictional challenge had been brought in Singapore in respect of an investor-state arbitration. The Court proceedings resulted in a subsequent SIAC international arbitration where the Government of Laos prevailed by a majority decision.

- **Private Banking Disputes**

Cavinder has acted for various international banks including representing UBS AG in a multi-million dollar dispute where two customers sued UBS for negligent advice and various other allegations surrounding the losses suffered by a US\$60 million investment portfolio in the aftermath of the global financial crisis in 2008. Under cross-examination, the investors admitted numerous falsehoods and ultimately withdrew their defence and counterclaim. The case had extensive media coverage.

- **Landmark decision in PT Perusahaan Gas Negara Persero TBK v. CRW Joint Operation (Indonesia)**

Obtained a landmark decision from the Singapore Court of Appeal on the interpretation of the FIDIC contracts which are widely used internationally in the construction industry. Previous lawyers for the client, CRW Joint Operation (Indonesia), had earlier sought to enforce an interim arbitral award issued by an adjudicator but

this was refused by the Singapore Courts and the Court of Appeal. A new interim award was issued and the new legal team led by Cavinder persuaded the Singapore Courts that the correct interpretation of the FIDIC provisions required the enforcement of the interim awards. This case has been the subject of many articles in legal journals and commentaries as it deals with the common practice of interim payments in international construction projects and the commonly used FIDIC form of contracts. This decision of the Singapore Court of Appeal was runner-up in Global Arbitration Review (GAR)'s "Most important published decision of the past year" award, handed out at the GAR Awards 2016 ceremony on 2 March 2016 in Shanghai.

- **Represented Singapore ticketing giant in a landmark appeal against the Competition Commission of Singapore**  
Represented ticketing giant, SISTIC, in an appeal against the Competition Commission of Singapore for alleged abuse of market dominance. The landmark case was the first abuse of dominance case to reach the Competition Appeals Board and set the law for abuse of dominance in Singapore.

## International Arbitration

- **Sharp v Hisense**  
Acted as lead counsel for Sharp Corporation in an international arbitration relating to a US\$3 billion contractual relationship relating to the sale of Sharp televisions in various territories. The dispute involved emergency arbitrator proceedings and related Court litigation in multiple jurisdictions. This case was reported in Global Arbitration Review and in various media publications in the United States.
- **Billion-dollar Indian Premier League dispute**  
Acted for an international sports marketing and media right management group in three separate arbitrations arising from broadcasting and media rights to the Indian Premier League, a major cricket event. The agreements involved in the arbitrations were worth over US\$1.2 billion. The dispute also involved multiple legal proceedings in India, USA, UK and in Singapore, and required intensive work with various foreign counsel in those jurisdictions.

- **Set-aside part of an \$80 million ICC arbitral award**

Successfully persuaded both the High Court and the Court of Appeal to set aside part of an ICC award on the grounds of breach of natural justice and excess of submission to jurisdiction. In its judgment, the Court of Appeal acknowledged that "It is not common in Singapore for awards to be set aside, and the courts have only done so in exceptional cases when the grounds are clearly made out", and that in over 20 years, only around 20 per cent of appeals to set aside arbitration awards had succeeded. The Court of Appeal's judgment is a landmark decision which addresses several key and novel issues, such as the Court being empowered to make consequential and/or ancillary orders to give effect to the setting aside of an award.

- **Billion dollar mining arbitration**

Acted for a major Australian mining corporation in arbitration against a major global engineering and construction company relating to a multi-billion dollar mining, rail and port project in Australia. The quantum of damages sought in this case was about one billion dollars.

- **Investor-State arbitrations**

Cavinder has acted as counsel in investor state arbitrations; and has experience acting for States and investors. He has also sat as an arbitrator in investor-state arbitrations under the auspices of ICSID, NAFTA and the Permanent Court of Arbitration (PCA); including the following non-confidential cases:

*City-State NV, Praktyka Asset Management Company LLC, Crystal-Invest LLC and Prodiz LLC v Ukraine* (ICSID Case No. ARB/14/9): Appointed President of the Tribunal in respect of a claim against Ukraine brought by Dutch entity City-State N.V. and other banking investors under the Netherlands-Ukraine BIT, which concerned the Dutch entity's deposits in Ukrainian bank PJSC Kreditprombank.

*Tennant Energy v Canada* (PCA Case No 2018-54): Appointed President of a Tribunal constituted under the auspices of the North American Free Trade Agreement (NAFTA). The claim was brought by a US corporation concerning its alleged investment in Skyway

127, an enterprise that proposed to develop a wind farm in Ontario. It was alleged, amongst other things, that Ontario's administration of the Feed-In Tariff program was non-transparent and opaque, and that government records documenting the alleged unfair energy regulatory measures were intentionally destroyed.

*Rizzani de Eccher SpA, Obrascón Huarte Lain SA and Trevi SpA v State of Kuwait* (ICSID Case No. ARB/17/8): Appointed President of the Tribunal in the first ICSID claim against Kuwait brought by an Italian-Spanish consortium under Kuwait's bilateral treaties with Italy and Spain, which concerned a billion-dollar project to upgrade a major highway in Kuwait.

*Agility Public Warehousing Company KSC v Republic of Iraq* (ICSID Case No. ARB/17/7): Appointed as President of the Tribunal in the first ICSID claim against the Republic of Iraq. The claim relates to an alleged investment in the telecommunications section in Iraq by a Kuwaiti company.

*ConocoPhillips UK, Perenco UK and others v Vietnam* (PCA Case No. 2018-5): Appointed President of the Tribunal for a claim under the UK-Vietnam BIT in respect of whether capital gains tax was payable following the sale of ConocoPhillips UK's operations in Vietnam to Perenco UK. The operations in question were held by UK subsidiaries of ConocoPhillips UK and included significant interests in two offshore oil blocks and in the Nam Con Son pipeline.

*Richard N. Westbury, Paul D. Hinks and Symbion Power Tanzania Limited v United Republic of Tanzania* (ICSID Case No. ARB/19/17): Appointed President of the Tribunal in respect of a claim against Tanzania brought under the Tanzania-United Kingdom BIT.

*Karkey Karadeniz Elektrik Uretim A.S. v Islamic Republic of Pakistan* (ICSID Case No. ARB/13/1): Appointed as a member of the Annulment Committee.
