EXPERIENCE

Some of the notable matters which Gerald has handled include:

International Commercial Arbitrations

- Acting in a failed-merger dispute worth US\$3.8 billion between two NASDAQ listed companies. The dispute is governed by Delaware and Cayman law and involves claims of material adverse effect.
- Acted for joint venture partners in a dispute relating to the development of a golf and country club, condominium residences and undeveloped land in Thailand, in SIAC arbitrations and related litigation before the Singapore High Court. The US\$40 million dispute involved allegations of conspiracy, breach of fiduciary duties and contractual breaches.
- Acted for a major Philippines water and wastewater services provider for the Greater Manila Area against the Philippine government in resisting the Philippine government's application to set aside an

arbitral award worth more than US\$62 million.

- Acted in an agency dispute administered by the SIAC relating to the procurement, distribution, sale and marketing of rubber and latex products in Europe and Africa.
- Acted in an application before the Singapore High Court to set aside an ICC jurisdictional award. The underlying claim related to the sale and distribution of apparel in South Korea.

Infrastructure Matters

- Advising a Japanese-Indian consortium on a US\$25 million dispute governed by Indian law relating to the construction of the Western Dedicated Freight Corridor, a major railway in India.
- Acted in an UNCITRAL arbitration and related set-aside proceedings involving claims worth more than US\$135 million in relation to the construction of an Ultra Mega Power Project (an integrated power generation and coal mine project) in India.
- Advised a major Japan-based shopping centre developer on the management and development of its landmark Singapore property, Takashimaya Shopping Centre.

Energy Disputes

- Acted for a Chinese state corporation in resisting an application before the Singapore International Commercial Court to set aside an arbitral award concerning the exploration and production of oil and gas resources in offshore China.
- Acted in a trust dispute before the Singapore High Court involving oil & gas assets worth more than US\$115 million, with related proceedings in the US and the Bahamas. Within this lawsuit, successfully resisted an anti-suit injunction application and obtained a stay on *forum non conveniens* grounds. Both decisions were upheld before the Court of Appeal.

Regulatory Actions

- Advised the private arm of a Singapore sports, entertainment and lifestyle publicprivate-partnership consortium on investigations by the Competition and Consumer Commission of Singapore, and acted for the same client in a related tender process to select ticketing providers, which included drafting tender documentation, technical specifications and the final contract.
