ABOUT MAN ER

EXPERIENCE

Man Er has assisted clients to resolve a variety of disputes. These include disputes relating to contract, tort, banking and finance, property law, equity and trusts, company law and shareholder disputes, insolvency and the enforcement of arbitration agreements and arbitral awards.

Man Er also has significant experience in corporate, anti-money laundering and regulatory investigations. She has advised companies in the banking and financial services, transport, hospitality, construction and manufacturing industries on all aspects of their investigations as well as regulatory enforcement and compliance issues.

Some of the matters which Man Er has acted in include:

Litigation

- Successfully acted for clients in matters before the Singapore Courts relating to the setting aside and enforcement of international arbitration awards. One of such cases is *Bloomberry Resorts and Hotels Inc and another v Global Gaming Philippines LLC and another* [2021] 2 SLR 1279.
- Successfully struck out a multi-million dollar claim brought by a foreign joint

venture partner against a Singapore listed company shortly after the claim was filed in the Singapore High Court.

- Successfully struck out a claim brought by an investor against an international bank for losses suffered in respect of foreign exchange derivative transactions.
- Successfully represented a Senegalese company in persuading the Singapore Court of Appeal to set aside the leave granted by the High Court to a Singapore company to serve claim documents on the Senegalese company out of jurisdiction. The Court of Appeal's decision is reported at [2021] 1 SLR 342.
- Successfully represented the owner of a business marketing government-funded training programmes in an appeal to the Appellate Division against findings of fact made by the trial Judge, after taking over conduct of the matter for the purposes of the appeal. The case is reported at [2022] SGHC(A) 36.
- Successfully represented a Singapore listed company in appeals before the Court of Appeal relating to an application by that company for legal proceedings to be stayed in Singapore on the ground that the Kingdom of Saudi Arabia was the more appropriate forum to hear the dispute. The Court of Appeal's decision is reported at [2017] 1 SLR 907.
- Successfully represented the "effective wife" of a prominent doctor, at trial and on appeal, in a dispute over assets valued at more than \$20 million. The case involved the application of the Mental Capacity Act. Indemnity costs were ordered in favour of the client. The case is reported at [2012] 1 SLR 549.
- Successfully applied for an anti-suit injunction against legal proceedings commenced in India in breach of an arbitration agreement.
